Ann Kramer, former Executive Director of the NFCA, meant everything to her beloved family and dedicated friends. She was a caring and devoted mother to her daughter Kara and loving wife to Jeff, her husband of 18 years.

She was a humanitarian with a passion for helping others. She was relentless in her research of medical advances and advocating for NF. During her time as Executive Director of the NFCA, she took the organization to a new level of professionalism.

A graduate of Hollidaysburg High School and the University of Pittsburgh at Johnstown, Ann's passing at the age of 41 from breast cancer was a profound loss for the many of us whose lives she touched.

Ann's impact and memory will live through her family and the support we give to the causes she embraced.

In her memory, the NFCA created the Ann Kramer Education Fund for tutoring services. Children with NF, grades 2-12, demonstrating learning disabilities and financial need are eligible.

The NFCA is a local nonprofit organization dedicated to maximizing the quality of life for families afflicted by NF. We are an advocacy and information resource for health care professionals, educators, patients and the general public throughout Southwestern Pennsylvania and surrounding regions. We champion patient care including medical, mental, social and educational issues by offering social services, school interventions, clinical case management and educational growth via tutoring (2-12) and post secondary school scholarships.

What is NF? Neurofibromatosis (NF) is one of the most common of genetic disorders. Despite this fact, most people are unfamiliar with the disease. NF is a progressive disorder of the central nervous system that can affect many different systems of the body in various ways. Each case is different and requires a unique set of medical specialists and a plan for management. One symptom of NF is the progressive growth of benign tumors (neurofibromas), which can cause major cosmetic issues, vision or hearing loss, bone deformities and many other physical problems. Aside from the many physical problems associated with NF, about half of all children diagnosed with NF have cognitive deficits or learning disabilities that qualify them for educational assistance. By identifying specific classroom challenges at a young age, parents and educators can help these affected children avoid and counteract common pitfalls such as social isolation, anxiety and depression.
